

Town of Bartlett Board of Selectmen
Meeting Minutes: September 21, 2007
Attendance: Chairman Gene Chandler, Douglas Garland
Absent: Jon Tanguay

Meeting opened at 09:00 AM.

Chairman Chandler recused himself from meeting with an individual who was requesting town assistance. Therefore, in the absence of Selectman Tanguay a telephone call was placed to Selectman Tanguay to discuss this request for aid. Selectman Garland met with the individual and as agreed by Selectman Tanguay assistance was granted.

David Eliason (3RT302-290-R00) discussed his web site with the Selectmen. Eliason would like to add the Selectmen's meeting minutes as well as other town information to his web site. Selectman Garland stated that the Town of Bartlett does have its own web site and Eliason could go to the Town's site and download to his site. Eliason remarked that the Town's site had suddenly come alive. Selectman Garland stated that it was not sudden as we have been working on the web site for six months or more. Chairman Chandler mentioned that we did advertise but didn't get any response but are anxious to get going. Selectman Garland stated that we are receiving a good deal from C. Harrison as he contributes 20 hrs. a month free for the Town and that ours was the official town web site which is .org.. Our site has just been slower getting going as everything that goes on our web site is reviewed by the Selectmen first. Eliason stated that he had downloaded the Town's Zoning Ordinance on his web site. Selectman Garland cautioned Eliason that if we change an ordinance that it may go unseen on his web site. Eliason has his Sky Valley web site and has had 5000 visitors to that page. Selectman Garland inquired if Eliason is able to tell if it is local inquiries or out of state inquiries. Eliason stated that he isn't able to determine that. Selectman Garland stated he doesn't mind Eliason linking to the Town's site as he probably has a much broader site than ours. Selectman Garland also stated eventually there will be a lot of documents on our site and you will be able to print out building permit application forms. Selectman Garland inquired about ad sponsors. Eliason stated that he presently has ads for Langdon's, Bartlett Inn, and Matty B's. Selectman Garland stated that all this energy should start with Bartlett Business Association. Eliason stated that he was on the original board and if you

google on Bartlett that his web site comes up first. Eliason inquired about obtaining the minutes for the Selectmen's meetings. Selectman Garland stated that the minutes are not instant and would take at least a couple of weeks as they have to be typed, and then reviewed by the Selectmen before they can be released. Eliason stated that he has tried to get other organizations, etc. interested in his web site, but so far the Bartlett Firefighters Association is the only one who has responded to him. The Selectmen gave Eliason a copy of the August 10th Selectmen's meeting minutes. Eliason stated that he had spoken to the tax collector/town clerk and she will be giving him all the tax payers' names, addresses, etc.

Bill Masters of Storage Kingdom, LLC (Mtn. Valley Storage – 1RT016-201-L00) stopped by to discuss brush clearing at his property as he would like to dress up the appearance of the business and increase the security at the site so the police would have better visibility if anything was going on at night. Photos were shown to the Selectmen and it was decided that they would stop by and view the lot to make sure the green area wasn't being disturbed.

Selectmen reviewed correspondence, building permits, signed letters and checks prior to and throughout the meeting.

Meeting adjourned at 11:00 AM.
